The 9<sup>th</sup> Annual PRRES Conference was held in Brisbane, Australia from 19-22 January 2003 and was an outstanding success. It was jointly organised by the Queensland University of Technology (QUT) and the University of Queensland (UQ), with the Sunshine State turning on perfect weather. The conference commenced with a welcome reception and registration at the QUT campus in central Brisbane overlooking Brisbane's Botanical Gardens. The actual conference was held in Old Customs House on the edge of the Brisbane River with accompanying majestic views. The presentations were conducted in three parallel sessions with a number of meetings held at various times over the four day period, commencing with the PhD forum on the Sunday afternoon.

The conference dinner was held aboard The Kookaburra River Queen, being a paddle wheeler that cruises the Brisbane River whilst enjoying dinner and the ever changing views of Brisbane. The conference concluded on a high note and looked forward to meeting again in 2004 for the Bangkok conference.



## PRRES Member Profile – Garrick Small

Dr Garrick Small is a Senior Lecturer at the University of Technology Sydney and specialises in the areas of Property Theory, Real Estate Finance, Professional Ethics, Land and Culture and Political Economy. His PhD was in “An Aristotelian Construction of the Social Economy of Land”.

As the photos indicate, we have the before and after Garrick Small. Garrick is married to Ellen and they have eight lovely children. Both Garrick and Ellen share strong family values and spend a lot of their time in educating their children in home schooling. Thus, Garrick is teaching from kindergarten to supervising PhDs.



In his early days, Garrick worked as a land surveyor and has now become a leading academic in several areas. 2002 – a year in the life of LMD at USP

The year got off to a great start at PRRES 2002 in Christchurch with the announcement of Timoci Waqaisavou as the (inaugural) 2002 RICS Foundation Oceania PhD Fellow for his research on Tourism on Native Land. Native Land and Land Tenure are the core research focus of the Department of Land Management and Development at the University of the South Pacific.

This theme was highlighted at a major regional Symposium at USP in April, sponsored by the Food and Agriculture Organization of the United Nations and the RICS Foundation. The FAO/USP/RICS Foundation South Pacific Land Tenure Conflict Symposium attracted over 150 delegates from the Pacific Islands, Australia and New Zealand to investigate the land related conflict associated with the clash between traditional communal values and capitalist aspirations. The Symposium was convened by Associate Professor Spike Boydell, and developed his earlier initiatives for the FAO and UN Visiting Expert in Land Tenure role. Three national land workshops resulted from the Symposium, in Fiji, Vanuatu and Papua New Guinea. The team was actively involved in these, with Sevanaia Dakaica being invited to participate in Papua New Guinea, sponsored by AusAID. Spike Boydell was on sabbatical until May, and then Matt Myers took sabbatical to pursue his research on the valuation of customary land. Matt attended the FIG Congress in Washington in late April at the start of his sabbatical. In late October Sevanaia Dakaica went on sabbatical to pursue his land tenure research and will spend time at the Land Tenure Center in Madison Wisconsin after PRRES 2003.

The Land Management BA and the Diploma in Town Planning underwent a major review during the year, following Professor Stuart Gronow's visit as External Advisor from the UK. The course offerings have been restructured to allow more flexibility, with majors in Real Estate and Land Use Planning. A strong student cohort took an active role in fundraising and promotional activities for Open Day and with the local property industry, helping continue to raise the external profile of the department. A successful major field trip was held in Viti Levu, and circuit judges from New Zealand and Tonga presided over the fifth annual Moot Court in October, for the Statutory Valuation and Litigation course.

It was a big year for romance in the department, with Anupam Sharma (Graduate Assistant) and Wejendra Reddy (Tutor) both getting married in formal Hindu ceremonies in April and December respectively. PRRES members will remember Anupam and Wejen from their PRRES debut as new researchers in Adelaide. Wejen was awarded the University Gold Medal for best university thesis for his MA on Property Trusts in 2002 (the first Masters graduate in the department). He won a prestigious scholarship to attend the 2002 Youth Environmental Summit in Switzerland for three weeks in July, as a prelude to the World Summit in Johannesburg. The department maintained the gold standard this year as Anupam was also awarded the University Gold Medal for best university thesis for her MA investigating Rural Women's Access to Land – an Indo Fijian Hindu perspective, supervised by Spike and Seva.

### API News *(from Sally Allen)*

In 2003, the API has re-accredited courses conducted at Melbourne University and Curtin University for another 5 years, with a final visit to be conducted at the University of Western Sydney in October. The National Education Committee has produced an Accreditation Policies and Standards Manual, which outlines the API's desired outcomes for accreditation, and clearly describes the standards to be met, to achieve API accreditation. This Manual is available from the Director, National Education at National Office. The API Website is continually updated, and now lists the current Universities and courses accredited throughout Australia. At the end of 2002, the API accredited the offshore Plant and Machinery course, conducted by the American Society of Appraisers, to fill the void left by the demise of the RMIT Plant and Machinery course, due to lack of viability. The API and the NZPI will be exploring the options of getting a Plant and Machinery course running again as a partnership across the Tasman. If you have any thoughts on this, please contact the Director, National Education. The National Education Committee has recently developed a Post Graduate checklist which will assist students in determining their eligibility for API Membership. This form was sent to all accredited course coordinators, to be distributed to students if requested. The API is currently looking at the issues of Technical Membership of the API and the Signing of Valuations. Due to the demand for valuers, the Institute is producing a paper that addresses market needs with several solutions to the problem. Once this paper has been refined, it will be circulated to Divisions, Boards, Members and Universities for comment. API National President, Mr Mike Collins has vowed to address this issue by Christmas. The API also accredited the course for graduate to become a certified practicing valuer.
