University Of Technology Sydney
Some current trans-disciplinary research @ UTS.

This year has seen a sharp and welcomed increase in trans-disciplinary research in the School of Built

Environment at UTS, writes Sara Wilkinson. Working with marine biologists, ecologists, entomologists, urbanists, urban planners, town planners, landscape architects Sara has been part of NSW Environment Trust funded, Urban Ecology Renewal Investigation project which will produce a Blueprint for NSW in early 2017. The Green Infrastructure theme features in the Horticulture Innovation Australia funded research that examines whether a mandatory or a voluntary approach to green roofs will work best in Australia.

Another local green roof project in Sydney explores the impact of a horticultural therapy programme on the health and well-being on mental health care consumers. Sara is working with UTS Faculty of Health colleague Fiona Orr, a psychiatric nurse on this project

New Book

Dr Obeng-Odoom is an urban economist, a former UTS Chancellor's Postdoctoral Fellow and the winner of the 2015 Patrick Welch Prize from the Association for Social Economics. He is also the author of a new book, *Reconstructing Urban Economics: Towards a Political Economy*, which throws up a resounding challenge to the profitoriented and system-conforming and extending analysis that defines the urban economic mainstream.

"The book seeks to contest the prevailing view amongst built environment academics and practitioners worldwide that to be analytical is to be abstract, and to be system conforming is to be industry relevant," Dr Obeng-Odoom says.

Exciting new project

Professor Deborah Levy, Head of Department of Property, and Emeritus Professor Harvey Perkins have been awarded National Science Challenge (NSC) research fund on the theme of "Building Better Homes, Towns and Cities". Their research project, as a part of a NZ\$2.5 million funded NSC project, will produce new knowledge to support and advance regeneration practice in 2nd tier settlements. The project arises out of concern about the considerable variability in the success of regional settlements in Aotearoa New Zealand. This project will be co-worked together with Dr Michael Mackay (Lincoln University), and Dr Malcolm Campbell (University of Canterbury).

Dr Zhi Dong has been awarded 2017 Visiting Fellowship of the New Zealand Centre at Peking University.
